#### **RESOLUTION #2024-41**

### A RESOLUTION IN SUPPORT OF SENATE NO. 725 CONCERNING UNLAWFUL OCCUPANCY OF DWELLINGS AND SUPPLEMENTING TITLE 2C OF THE NEW JERSEY STATUTES OF THE STATE OF NEW JERSEY

WHEREAS, the occupancy of a dwelling without the permission of the property owner, also known as "squatting" is an increasing occurrence throughout the State of New Jersey and the Country; and

WHEREAS, persons engaging in squatting often do so with the express intention of depriving the lawful property owners of the use and possession of their own property for as long as possible, with the express knowledge that squatting is not a criminal offense, thus requiring a property owner to undertake expensive, time-consuming civil litigation to recover their property, which said litigation can be subject to delay tactics including, but not limited to, bankruptcy applications, resulting in squatters successfully depriving lawful owners of the use and benefit of their own property for extended periods of time; and

WHEREAS, Senators Steinhardt, Testa and Polistina have introduced and are sponsoring Senate No. 725, which said legislation would establish squatting in various contexts as criminal offenses and crimes of the fourth degree, thus permitting property owners to avail themselves of filing criminal complaints with local law enforcement that can be duly investigated, and, when appropriate, permit police officers to arrest and remove persons found to be engaged in said criminal squatting activities.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee that it hereby adopts this Resolution to memorialize its support for Senate No. 725 and certified copies of this Resolution shall be forwarded by the Township Clerk/Administrator to the Office of the Governor and Lieutenant Governor, the Township's elected Representatives in the State Legislature, and the New Jersey League of Municipalities.

Miller, P.J.Cv. by order dated January 3, 2018, Docket No. WRN-L-224-15.

#### Engineer -

**Millbrook Road** – it is the first day of construction of the Stormwater Replacement Project. As to the FEMA Restoration Project the Invitation to Bid will be advertised this week and the bid opening is scheduled for May  $29^{\text{th}}$ . We should be able to award the contract at our June  $3^{\text{rd}}$  township meeting. Mr. Finelli spoke with Hillary Trotman inquiring about an extension before the project starts just for comfort if needed. The completion target date is still the end of July.

**The Dioxane project** – We are still waiting on two agency approvals, one from the railroad the other from the county then we can go out to bid.

**2024** NJDOT Grant – Good Springs/Willow Grove Road, we are not able to move forward with this project. However, the 2025 NJDOT Grant just came out and is due July 1<sup>st</sup>. We can re-apply for the same roads asking for additional monies. The engineer will coordinate with the DPW Foreman.

Attorney – Will take care of the documents to close on the property just auctioned off.

# **Committee Reports:**

**Bonnie Butler** – A neighbor of hers received one of the auditor letters and seems to be confusing those that receive. Mayor Guth informed that this letter is for polling purposes and not to cause alarm and apologizes for the problems incurred and the non-representation in the tax office.

**Sarah Payne** – The MWA is embarking on a project to vitalize the Village of Asbury and if we don't may be left back in time. This would encompass traffic control, rezoning for homes and businesses to name a few. The concept that was outlined in their presentation is to embarks on a survey before they go any further to the residents. Funding is a concern as well as other things.

**Michael Toretta** – Would like to hire Ron Read for roadside mowing. Further discussion to ensue in executive session. A reminder that he is only allowed to work up to 25 hours due to our pension system.

Rich Herzer – Nothing further to report.

David Guth - Nothing further to report.

**Open Space/Agricultural Advisory Commissions** – nothing further to report.

Zoning Officer – Report submitted and on file.

**Franklin Twp. Fire/EMS** – Crissy Brown reported that there were 93 Ems calls and 34 fire calls. The first annual car show was a success, thanks to Jason Banghart, OK 4WD, Dave Leary, and Broadway Auto. Two members in EMT class, hopeful to get them up and ready to go. Attorney Benbrook had a discussion with the chief, current insurance carrier will be non-renewed due to loss experience making them difficult to insure. They have been in contact with our insurance representative, Ahart, Frinzi & Smith as well as another broker looking into all different options to obtain proper coverage.

**DPW** – Report submitted and on file – The contractor for the brush pile still has not shown up and the pile continues to get larger. We may have to go with the second contractor, that was \$1000 more. Consensus would be to go with the other contractor since this one is not showing up and honor their quote as submitted.

Committeeperson Butler advised that per our CFO the American Rescue Funds must be used by the end of this year. \$70,000 has been put to the side for improvements to be made at the road garage; salt shed and maintenance of the building, the rest of the funds put towards oil/chip of township roads.

Recycling Coordinator – No report submitted.

**OEM/911** Coordinator – OEM Tabert – Working currently with weekly FEMA stuff. Moving forward with Montana Road and the six other roads damaged by the storm. The Category B emergency dig northside of Rt. 57

and Pohatcong Creek which was flowing back into the town of Broadway. Checking boxes to get our reimbursement under way. Per Mayor Guth, the township property that Mr. Truszkowski currently farms, where solar lines go through, manhole covers bubbling up with water. Mayor spoke with Attorney Bellin whatever damage caused due to storm and should not have damaged or bearing on anything underground that he believes. Mayor will follow up with him tomorrow. Next phase, southern portion, may get approved for something but doesn't look that way at this time even with an appeal. Congratulations to Ms. Tabert on obtaining your Nursing Degree.

FTYA- no representation present.

At approximately 8:02 p.m. Mayor Guth opened the floor to the Public.

Cathy Montgomery – residing in the first home on Stewartsville Road, would like to coordinate with Habitat as to any buffering/privacy they might be proposing that borders her property.

Ron Hickey/Cristiana Pinto – Residing on Olde Street since July storm demographics of the water have changed. They are taking in a lot more water in their basements and pumping continuously. Mayor informed this has nothing to do with Millbrook Road as the river has been rectified to its normal flow. This is Mother Nature and a rise in the groundwater tables. Zoning Officer Onembo advised that the area has always had water problems and pumping out of basements.

Marsha Colaluce – Prior to the demo of the old Hunters building is in such a bad/dangerous condition and fully dilapidated and cannot allow anyone in this structure. Looking for any historic keepsake to be used as a monument to preserve. There is no historic significance. Victaulic owns the Thomas Edison piece Franklin Township owns the contaminated piece. Also, liter on our roads is so bad, the Cub Scout Pack #56 Pohatcong/Greenwich/Alpha collected 15 bags of litter from Rt. 57-Good Springs Road. Do Not Liter signs on Edison Road, the mayor informed this is a county road will have to bring up to the county and Mr. Onembo as our Code Enforcement Official can issue summonses on his end.

Karen Chiu – Do we have any money for cleaning roads. Committeeperson informed that there is money available through our Clean Communities Grant for volunteer groups to clean our roads.
