#### **ORDINANCE 2024-3**

AN ORDINANCE APPROPRIATING \$52,400 FROM CAPITAL IMPROVEMENTS AND \$87,600 FROM THE NJDOT 2022 GRANT FOR MILLBROOK ROAD FOR IMPROVEMENTS TO MILLBROOK ROAD PHASE 2 IN THE AMOUNT OF \$140,000.00.

**BE IT ORDAINED,** by the Township Committee of the Township of Frankin, in the County of Warren, State of New Jersey, as follows:

**SECTION ONE:** The sum of \$52,400 from Capital Improvements and \$87,600 from the 2022 NJDOT Grant are

hereby appropriated for Improvements to Millbrook Road Phase 2 in the amount of \$140,000.00

**SECTION TWO:** Ther period of usefulness of the above project as defined by NJSA 40A:2-22 is at least 5 years.

**SECTION THREE:** The capital budget of the Township is hereby amended to conform with the provisions of this

Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey is on file with the Township Clerk and is available for

public inspection.

**SECTION FOUR:** The gross debt of the Township of Franklin as defined by NJSA 40A:2-43 will not be increased

by this ordinance.

**IT IS FURTHER ORDAINED** that this Ordinance shall take effect 10 days after publication, following final adoption, as provided by law.
